Chair's Report

I am proud to present my second annual report 2015/16 as Chair of Pollokshields Development Agency. It has been a challenging yet productive year on various fronts, maintaining sustainability of our projects, as well as planning and delivering more exciting services, building new partnerships, and devising a contemporary strategy.

Given the recent scrutiny by the banks in relation to the operations of accounts and the requirement of due diligence as an important precursor to The Money Laundering Regulations 2007 - Section 5, PDA faced an uphill task. However finally with the will of Allah we were successful and fully able to open our new Treasurers Account. This unique account is benefiting PDA in many ways giving us opportunity to effectively organise our finances with added optional monetary support.

Like many third sector organisations PDA has suffered in this current economic climate, we too re-evaluated our funding and overall financial strategy to ensure that we do not fall victim to financial constraints. Our skilled board of directors have devised an organisational fiscal to ensure we overcome any predicaments. We have introduced a more advanced system of financial accounting to facilitate transparency and effectiveness. With efficient use of our resources we have managed to reduce PDA's salary bill by 23.5K i.e. a 42.86% saving resulting in a surplus of £4451 this year.

The resignation of our project manager caused a major resource and capacity challenge in the management of staff and daily operations. To manage this challenge, members of the board invested their personal time to ensure the delivery of projects and services, managing staff and finances.

I am pleased to say we have now employed a new project development officer and have a pool of sessional staff and volunteers to help us in the delivery of our forthcoming projects. This would not have been possible without the help of IGF and GCVS personnel for their guidance and professional input in the recruitment process.



The office is now running efficiently and furthermore the staff are undergoing capacity building professional training sessions, to learn new skills and to enhance efficiency and project activity.

Dear members, to counter the financial and human resource challenges this year the board of directors steered towards the ethos of Partnership working on the following three new projects :**Urdu Higher** in partnership with Scottish Opportunities Centre, **Keep Shields Beautiful** in partnership with Scottish Youth Forum and **Wild in the woods** working with Iqra Learning Centre and The Forestry Commission .

We are aware that children from black and ethnic minority backgrounds are under-achieving at local schools compared to their indigenous peers and we are making authorities aware of the community deficit and at the same time searching for funds to accommodate the **Home School project** at PDA. The programme will provide tutorials in Maths, Science and English to support children with their homework with the help of professional teachers.

The Home School Project will enhance the children's academic achievements at schools and increase their opportunities to advance to further education and employment; an ultimate resource to alleviate poverty-stricken families.

Pollokshields is home to many diverse communities and since their arrival in Glasgow members of the black & minority ethnic community have been actively contributing to the local and national economy and have taken a keen interest in the development of their communities. In the mid-eighties, a group of likeminded individuals formed a steering group to look at the needs of local communities in Pollokshields and is still here in its present form of Pollokshields Development Agency.

In recognition of this it would be timely to celebrate this thirty-year legacy and recognise the achievements of the community. A sub group of PDA directors are working on a **Legacy Project** to showcase the history and achievements of people of Black & Minority Ethnic backgrounds.

It is my pleasure to report to you that Board of directors have completed three sessions of training and development with Jobs and Business Glasgow to facilitate the **community asset transfer** of Pollokshields Community Centre. This process has been identified as having a role in inspiring people, creating opportunities and potentially transforming communities by helping them respond to these challenges and by taking even greater control of land and building where they live. To this end we are working with a Social Enterprise Adviser from Jobs & Business Glasgow to facilitate our aims and objectives for a new PDA.

Finally, my sincere thanks to the board of directors for their hard work and especially sister Nazim Hamid for the timely help in managing day to day operations, shaping the future of PDA, supporting me to devise the PDA strategy in line with contemporary developments.

I am also grateful to the staff for their commitment and support throughout the year for the smooth delivery of services to our communities.

Last but not least I would like to thank members of PDA and the local community for their invaluable support without whom there would not be a PDA.

Treasurer's Report

Over the last few years the full impact of the financial crisis has slowly emerged. The continued cuts in public funding and decrease in grant funding across the voluntary sector has had a devastating effect. In many cases, unfortunately, local groups and organisations have been lost whilst others now work harder, in a highly competitive funding environment, to obtain core funding so they can continue to deliver essential services and support to the communities they serve.

Pollokshields Development Agency (PDA) has not been immune to the financial situation. Over the last year the organisation has faced the potential loss of core funding and various funding streams that were used to pay for staff and our projects for young people and the elderly community. Working closely with Glasgow City Council and other funders, PDA has been successful in reinstating the core funding to 2018. This has been used to recruit a new Project Development Officer to support the current work and help create new projects and services. In addition to the above, PDA has successfully obtained three other funding packages to allow us to continue our Senior Citizen's Club and Playscheme.

Other applications are currently in progress to provide for new sessional staff and projects for young girls, parents and toddlers and health activities, exercise and educational programmes for 2017.

All the current activities are now supported by new financial management systems and reporting processes, ensuring PDA delivers high standards as an organisation and has transparent and accountable procedures.

My role as the Treasurer for PDA comes to an end in November, however, I am assured the organisation is in a position that it can continue to serve the residents and communities in Pollokshields for the next twenty-nine years, building on the foundation created this year. PDA has the adaptability to face new challenges whilst ensuring stability of the core provisions and services.

I wish the Board of Directors of PDA, the staff and, more importantly, the residents of Pollokshields the very best for the years ahead.

Senior's Lunch Club



Another successful year for our Senior Lunch Club Project funded by Voluntary Action Fund.

The main aim of the lunch club project is to offer a weekly social programme, introducing recreational outdoor activities, learning and development activities for our seniors aged 50+.

PDA's lunch club project has helped many marginalised and isolated seniors to build their confidence and increase their independence. Many have created new friendships and look forward to their weekly visit to the PDA.

We successfully worked in partnership with Diabetes UK and Royal National Institute of Blind People (RNIB) to raise awareness among service users around the importance of eye health and managing their diabetes whilst fasting.

We aim to ensure that this project remains sustainable by continuing to offer social interaction, encourage a healthier lifestyle and provide information on a range of topics that address the needs of older people. To ensure we remain on the right track we regularly undertake informal consultations.

PDA Playscheme Holiday Programme



We operate a programme of activities for school aged children and young people during the Easter, Summer and October holidays. This programme provides young people from Pollokshields with a safe and stimulating environment where they can take part in fun activities with their friends and make new ones.

- Activities include games, sports, arts and crafts, outings and special projects. The scheme operates 5 days per week during school holidays .

Our holiday programme is funded by Glasgow City Council. The programme allows us to engage directly with children to discuss issues that may affect them such as outdoor child safety, online bullying and other forms of violence. This allowed children to gain a better understanding of dangers that exist with the ability to respond appropriately in different environments and to ask for help.



We continue to look at innovative ways to deliver a better service. We value the support, input and ideas from our young service users. These conversations allow both staff and children to implement their suggestions through fun activities.

PDA Playgroup

The playgroup offers places to pre school children ages 3 to 5 years. We follow the curriculum of Excellence facilitating children to become successful learners, confident individuals, responsible citizens and effective contributors. We have also been able to access extra curricular learning activities for the children allowing them to benefit from increased physical activity, exposure to the arts and a variety of cultural opportunities as well as exploring their local environment and further afield. PDA is currently seeking funding to continue this important project.

Women's Group

The Women's group was set up to empower women to become more confident and be more socially involved and active. The project identified a concerning number of isolated women, fearing the unknown and having nowhere and nobody to turn to. We offered safe spaces, allowing women to meet, share stories, experiences and build on new friendships with other service users. The project received support from Voluntary Action Fund and Glasgow City Council.

Easy exercise classes were offered for women to improve their health, feeling the benefits of being more physically active and preventing early onset of ailments that ethnic minority communities may be more susceptible to such as heart disease and diabetes.

The PDA remains committed to helping vulnerable and isolated women, supporting them to build

- self-esteem and be part of a community shared and shaped by all. PDA is currently seeking funding to continue this important piece of work.



Urdu Project

Scottish Opportunities Centre in collaboration with PDA started delivering Urdu Language courses since September 2016. Courses delivered are Urdu National 4, National and Higher approved for this centre by Scottish Qualifications Authority.

An awards ceremony was held to celebrate a successful first year, with the SQA, local dignitaries and the community in attendance.



Community Transport & Minibus Scheme

PDA's Minibus is available for hire for local and private organisations at an affordable cost. The income generated has enabled the PDA to upkeep and maintain the minibus and continue to provide an excellent service to our clients.

This invaluable service has allowed the community to access outdoor recreational opportunities especially for those that have no access to their own transport or lack the confidence to use public transport.



PDA is planning to seek funds to recruit and train volunteer minibus drivers. This will enable more people to access this community transport service as well as help volunteers gain new skills, resulting in job opportunities.

English for Speakers of Other Languages

We are continuing to work in partnership with Glasgow Clyde College to deliver this ESOL Project.

Our aim is to provide a range of classes locally giving students the ability to progress from basic to more advanced levels of English.

At present we are offering ESOL testing, which is a requirement and allows tutors to establish what level of class would best suit each students' needs. We currently offer Access Level 3 classes twice a week.



We are continuing to explore new avenues to support our ESOL students to improve their employability, at present many go onto computing classes run in conjunction with Glasgow Life held in the Pollokshields Community Centre.

Wild in The Woods

PDA continues to seek out new partnerships and opportunities which will extend the services and support that can be provided to the residents of Pollokshields.

This year the emphasis has been on providing new provisions to young people, particularly regarding outdoor activities and inspiring active citizenship and environmental custodianship.

To this end, PDA has been working with ILC Darnley, a charity which is developing a new community centre, the West Hurler Community Hub (WHCH), in Greater Pollok. WHCH is unique in that it will provide a fully functioning community hub with meeting rooms and facilities, along with ten acres of woodland in which families and young people can enjoy nature and activities in a safe and culturally friendly environment.

In October, young people, through PDA attended the 'Wild in The Woods' sessions at WHCH. The event was delivered in partnership with The Forestry Commission.

The sessions allowed young people the opportunity to learn about nature, the environment and having fun. Over 30 children attended the sessions from across Glasgow, 8 children (with parents) from Pollokshields. The children had a wonderful time, playing in the outdoors, learning about different trees and plants, building a safe fire, camping and, more importantly, how to look after the wonder that nature provides. PDA hopes to continue to build the partnership with WHCH and participate in future sessions held on the grounds.





Pollokshields Clean Up

Keep Shields Beautiful” has made a big difference in reducing Fly-tipping in Pollokshields, we have also helped single mothers and elderly people to dispose of bulk refuse and helped them to clean their back courts.



Over the past 18 months, Fly-tipping has been reduced by 35%. We have arranged training sessions for our volunteers and to date we have signed up 60 Neighbourhood Improvement Volunteers. We have delivered group and one to one training for Pollokshields residents on how to use **MY Glasgow Mobile App** to report Fly tipping, Pot Holes, Dog Fouling, Graffiti and many more issues.

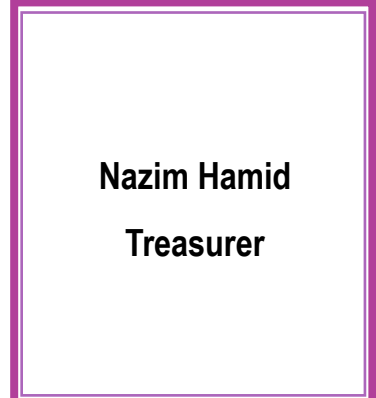
